#### Preparation:

Surface should be in sound condition, clean and dry and at a temperature between 32°F-90°F. Any repairs should be made before coating.

#### Mixing:

Products is supplied ready to use but should be stirred prior to use to eliminate any phase separation or settling which may occur upon shipping and storage.

#### Application:

Because of its fast drying properties, the product is best applied by airless spray but may also be applied by conventional air spray, brush or roller.

#### Coverage:

350 - 400 ft<sup>2</sup>/gallon.

#### Cleanup:

Clean tools and spills with xylene before the material dries.

#### Precautions:

This product contains organic solvents which have associated health and fire hazards. Minimize exposure by always wearing appropriate personal protection equipment.
